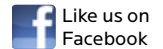

- 1. Description: Disney Family Movies' – The Magic of Europe Sweepstakes** ("Sweepstakes") begins on November 15, 2016 at 12:01 a.m. Eastern Time ("ET") and ends on December 19, 2016 at 11:59 p.m. ET ("Sweepstakes Period"). Sponsor's computer shall be the official clock for purposes of the Sweepstakes and all times (as hereinafter defined) refer to ET.
- 2. Eligibility:** Open to persons thirteen (13) years of age or older as of the date of entry, who are permanent legal residents of the fifty (50) states of the U.S. and the District of Columbia ("D.C.") (excluding Guam, Puerto Rico, and all other U.S. territories and possessions) and who are physically located therein. Entrants must have either a valid Social Security number or a valid U.S. personal tax identification number. If an entrant is deemed a minor in his/her jurisdiction of residence and resides in Alabama or Nebraska and is under nineteen (19) years of age; is a resident of Mississippi under 21 years of age; or, is under the age of eighteen (18) in the remaining forty-seven (47) states ("Minor"), he/she must obtain parental/legal guardian consent prior to registering at the Disney Family Movies website, entering the Sweepstakes, or submitting any personally identifiable information. Employees and agents of Buena Vista Television, LLC ("Sponsor"), The Walt Disney Company, Disney-ABC Home Entertainment and Television Distribution, Disney Destinations, LLC, Sweepstakes administrator, their respective advertising, promotion and web design agencies, and those involved in the creation, production, administration, development and handling of the Sweepstakes, their respective agents, officers, prize suppliers, parent companies, affiliates, subsidiaries, respective successors and assigns (collectively "Sweepstakes Entities") and members of their immediate families (parents, grandparents, children, siblings, spouse, domestic partner) and/or persons living in the same household as such persons, whether related or not, are ineligible to enter the Sweepstakes.

An entrant who is not registered on the Website may become a registered member for free by creating an account using his/her email address and completing the following data fields: first name, last name, email address, choice of password, date of birth and gender (optional) ("Registration Information") or using their Facebook Account information. To enter as a registered member, each entrant must first "Sign In" and complete the following Sweepstakes entry fields: street address, city, state, zip code, daytime telephone number, cable provider (optional), and select the eligibility checkbox ("Entry Information"). Once submitted, he/she will receive one (1) entry into the Sweepstakes ("Entry"). Entrants must be registered with the Website and/or one of the Walt Disney Family of sites in order to enter the Sweepstakes. If an entrant is already registered with the Walt Disney family of companies, no new registration is required. If an entrant opts to enter or register with his/her Facebook account information, each entrant must understand that the Sweepstakes is in no way sponsored, endorsed, administered by or associated with Facebook and Facebook is completely released of all liability by each entrant in this Sweepstakes. Sponsor has no affiliation with Facebook and no responsibility for (or control of) any matters relating to Facebook or Facebook accounts. **4. One (1) Grand Prize will be awarded:** Grand Prize winner will receive a seven (7) night European Disney Cruise Line vacation from either Barcelona, Spain or Copenhagen, Denmark for four (4) persons to be taken aboard the Disney Magic ("Vacation"). The Vacation includes: round-trip coach class air transportation for winner and up to three (3) guests between a major gateway airport near winner's residence and the major airport closest to the ship's homeport in either Barcelona, Spain or Copenhagen, Denmark; ground transportation to/from the designated airport and the Disney Magic's homeport; stateroom accommodations for four (4) (quad occupancy) aboard the Disney Magic (location/category selected at the discretion of Disney Cruise Line); all meals (excluding alcoholic beverages) aboard the Disney Magic (with the exception of Palo fine dining); pre-paid gratuities, taxes, fees and port expenses (as defined on the Disney Cruise Line website) (collectively, "Grand Prize"). **The total Approximate Retail Value ("ARV") of the Grand Prize: \$14,498.84. No extension or change of travel dates of the Vacation components may not be sold, traded, transferred, rescheduled to dates not within the fulfillment period set forth above, or refunded. Once the air travel tickets are issued they are non-refundable, non-endorsable and non-transferable. Grand Prize restrictions/conditions stated herein are not all-inclusive and may be subject to additional restrictions/conditions, which will be stated in the Affidavit/Release (as described below) and/or travel documents. Once travel has been confirmed, any cancellation or change fees or restructuring of the Vacation are the sole responsibility and expense of the Grand Prize winner (in Sponsor's sole discretion). If the potential Grand Prize winner cannot be reached after a reasonable effort within a five (5) day period, such potential Grand Prize winner will be disqualified, and an alternate potential Grand Prize winner will be selected in Sponsor’s sole discretion. If the potential Grand Prize winner is found to be ineligible, if he/she cannot or does not comply with these Official Rules, and/or if his/her Grand Prize notification documents or requirements are incomplete or returned as undeliverable, such potential Grand Prize winner will be disqualified and an alternate potential Grand Prize winner will be selected at Sponsor’s sole discretion. If the Grand Prize is forfeited after the Grand Prize winner has been verified (and there is sufficient time to determine and notify an alternate Grand Prize winner), the Grand Prize will be awarded to an alternate winner.

**6. General Conditions:** The Sweepstakes is subject to all applicable federal, state and local laws, and to these Official Rules (collectively “Rules and Laws”). By participating, each entrant agrees to: (i) be bound by these Rules and Laws and the decisions of the Sponsor/Sweepstakes administrator, which are final and binding in all respects; (ii) waive any right to claim ambiguity with the Rules and Laws; (iii) indemnify and hold harmless the Sweepstakes Entities from any and all claims, actions, injury, loss, damage or liability resulting or arising from the Sweepstakes, including but not limited to, the acceptance, possession, use, or misuse of any prize (or prize component) awarded; and (iv) release all right to bring any claim, action, or proceeding against the Sweepstakes Entities. Sponsor reserves the right, at its sole discretion, to disqualify any individual found to be (i) tampering with the Entry process or the operation of the Sweepstakes; (ii) acting in violation of the Official Rules; or (iii) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. GOVERNING LAW, JURISDICTION, ARBITRATION:** Any controversy or claim arising out of or relating to (i) the Sweepstakes, (ii) the awarding or redemption of the Grand Prize, and/or (iii) the determination of the scope or applicability of these Official Rules or their enforcement or interpretation shall be governed by and construed in accordance with the substantive laws of the State of Florida without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws. Each entrant agrees that any claim arising out of the Sweepstakes or these Official Rules will be resolved individually without resort to any form of class action. Each entrant further agrees that any claim/judgment/award shall be limited to actual out-of-pocket costs incurred, including costs associated with participating in the Sweepstakes and in no event will entrants be permitted to obtain attorneys' fees or other legal costs; and, under no circumstances, will an entrant be entitled to awards. Each entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or increased. Should any term of this Section be deemed void, unenforceable or contrary to law, such term shall, but only to the extent necessary to bring this section within the requirements of law, be deemed to be severed from the other terms of these Official Rules, and the remainder of these Official Rules shall be given effect as if it had not included the severed term herein. THE PARTIES HEREBY WAIVE THEIR RIGHT TO JURY TRIAL WITH RESPECT TO ALL CLAIMS AND ISSUES ARISING OUT OF OR RELATING TO THIS AGREEMENT WHETHER SOUNDING IN CONTRACT OR TORT, AND INCLUDING ANY CLAIM FOR FRAUDULENT INDUCEMENT THEREOF.
