During this sailing, Immigration Officials in Key West, Florida, will be coming onboard for a full Immigration Inspection. So that you may fully enjoy your time ashore and to comply with this Immigration regulation, all Guests, including children, must present themselves and their citizenship documentation to the Immigration Officials upon our arrival in Key West. Further details on timing and location of the inspection will be delivered to your stateroom the evening prior to our arrival in Key West.

While we truly regret any inconvenience, this is an Immigration requirement that applies to any ship sailing from a foreign port-of-call, like the Bahamas, to a port in the United States - in this case - Key West. Guests who fail to comply with this regulation may be subject to a per person fine issued by U.S. Immigration.

KEY WEST IMMIGRATION INSPECTION

Dear Disney Wonder Guest -

We trust that you are having a truly magical cruise!

We would like to remind you that **United States Immigration requires that EVERY guest, including children, present themselves in person** for Immigration inspection upon arrival on Key West morning. All guests should present Passports, Resident Cards, or Birth Certificates and a Valid Government Picture ID, as proof of citizenship, yet you will **not** require a Customs Declaration Form. **EVERY Guest will have to attend whether or not they decide to get off the Ship for the day. Failure to present each family member to the US Immigration Officers may result in a \$3,000.00 fine per family member from US Immigration**

Once you have completed the Inspection, you will be allowed to immediately disembark the ship and enjoy your day in port. **Be advised that EVERY Guest will need to bring their KTTW card (room key) with them, as Immigration officials will put a sticker on them as proof of attendance.**

Guests participating in Port Adventures will be required to present themselves to Immigration Officials **BEFORE** proceeding to the meeting point designated on your Port Adventures ticket.

Please refer to the attendance schedule below to ensure that any delays are avoided and you are able to fully enjoy your time ashore in port.

We kindly request for our US Guests to be in the Walt Disney Theatre and our Non-US Guests to be in Azure (Sea Treasures entrance) at the times stated below. Our crew members will be on hand to assist you and your family through to US Customs and Border Protection.

****Families with varying nationalities are asked to present themselves based on Non-US times and location.***

Whilst we regret the inconvenience, this is a U.S Immigration policy requirement that applies to any ship that goes from a foreign port (e.g. Castaway Cay) to a U.S port (e.g. Key West, FL), and we sincerely appreciate your prompt attendance.
