ONCE YOU'VE BOOKED YOUR CRUISE

- Download the [Disney Cruise Line Navigator app](#).
- Reserve premium activities—adult-exclusive dining, Port Adventures and more—online via [My Reservations](#), or through the [Disney Cruise Line Navigator app](#).

15 DAYS BEFORE SETTING SAIL

- For sailings from US and Canadian ports, every Guest 18 years of age and older must individually create an account associated with their reservation on the [Inspire Diagnostics Safe Passage](#) website and upload their proof of vaccination and/or negative COVID-19 test. Additionally, a parent or legal guardian will need to use their own account to provide this information on behalf of all minors.
- For sailings from European ports, every Guest 18 years of age and older must individually create an account associated with their reservation on the [Sail Screen](#) website by [Prenetics](#) and upload their proof of vaccination and/or negative COVID-19 test. Additionally, a parent or legal guardian will need to use their own account to provide this information on behalf of all minors.
- Guests choosing to order a testing kit from [Inspire Diagnostics](#) should order one so that they have it in hand at least 4 days before setting sail.
- Complete [Online Check-In](#). Be sure to select a Port Arrival time.

ONE TO 3 DAYS BEFORE SETTING SAIL

- Guests who are not fully vaccinated must provide proof of a negative COVID-19 test taken one to 3 days before the sail date.
- Upload your COVID-19 PCR test results or proof of vaccination to the [Inspire Diagnostics Safe Passage website](#) and ensure your account indicates those in your travel party are "Clear to Arrive" or "Clear to Sail" at the port. A parent or legal guardian must use their own account to submit test results or proof of vaccinations on behalf of minors.
- In some cases, people who have recently recovered from COVID-19 may still test positive for the SARS-CoV-2 virus. If Guests have tested positive for SARS-CoV-2 within 11 to 90 days of their sail date, they may qualify to be considered as "90-Day-Recovered." With the appropriate documentation and subsequent approval, Guests considered "90-Day-Recovered" are not required to participate in COVID-19 testing during the Pre-Sail, Embarkation or Disembarkation phases of their voyage. - For sailings aboard the [Disney Dream](#), [Disney Fantasy](#), [Disney Wish](#) and [Disney Wonder](#) through **September 22, 2022**, fully vaccinated Guests must provide proof of a negative COVID-19 test result (paid for by the Guest) taken one to 2 days before setting sail to be exempt from embarkation testing at the terminal on embarkation day. For sailings aboard the [Disney Dream](#), [Disney Fantasy](#), [Disney Wish](#) and [Disney Wonder](#) beginning **September 23, 2022** (and [Disney Magic](#) beginning **November 7, 2022**), fully vaccinated Guests will no longer be required to submit COVID-19 test results in order to sail.

EMBARKATION DAY

All Guests (adults and children, regardless of age) must:

- Complete the pre-trip Health Questionnaire (available via the [Disney Cruise Line Navigator app](#) and online).
- Bring proof of your COVID-19 results and vaccination status, along with your [Port Arrival form](#) with QR codes.
- For sailings aboard the [Disney Dream](#), [Disney Fantasy](#), [Disney Wish](#) and [Disney Wonder](#) through **September 22, 2022**, fully vaccinated Guests who do not upload test results to the [Safe Passage](#) website by midnight prior to embarkation day must be tested at the terminal on embarkation day before boarding and will be charged for the cost of the test. For sailings aboard the [Disney Dream](#), [Disney Fantasy](#), [Disney Wish](#) and [Disney Wonder](#) beginning **September 23, 2022** (and [Disney Magic](#) beginning **November 7, 2022**), fully vaccinated Guests will no longer be required to submit COVID-19 test results in order to sail.
- For sailings aboard the [Disney Dream](#), [Disney Fantasy](#), [Disney Wish](#) and [Disney Wonder](#) through **September 22, 2022**, in addition to uploading COVID-19 test results into [Safe Passage](#) by midnight prior to the sail date, Guests who are not fully vaccinated are also required to complete a second COVID-19 test at the terminal prior to boarding on embarkation day (paid for by Disney Cruise Line).
- For sailings aboard the [Disney Dream](#), [Disney Fantasy](#), [Disney Wish](#) and [Disney Wonder](#) beginning **September 23, 2022** (and [Disney Magic](#) beginning **November 7, 2022**), Guests not fully vaccinated will no longer be required to complete a second COVID-19 test at the terminal on embarkation day.
- Please be aware that Guests will not be permitted at the terminal or in parking areas before their scheduled arrival time. Guests who arrive early will be asked to return at their scheduled arrival time, and Guests arriving after their scheduled time may be delayed and asked to wait behind those arriving at their scheduled time.

BACK-TO-BACK SAILINGS

Guests who are not fully vaccinated on consecutive, back-to-back sailings, will be required to complete a COVID-19 test between sailings, paid for by Disney Cruise Line.
